Meeting called to order.

LH explained public comment & open meeting forum, along with role as chair

LH: Informational - purpose of APS SEAC, information about APS special education, and Robert's Rules of order.

Agenda Reviewed.

LH explained Purpose and Process of SEAP: The APS SEAC committee was established pursuant to Act 274 of the LA Legislation and adopted by Ascension Parish School Board policy IDDFA. (APS board policies found on website). Each spring a new group of committee members is selected by the Superintendent for the following school year. The purpose of the committee is to provide parents, district staff, and other community members an opportunity to provide feedback and recommendations to the Superintendent on issues regarding Special Education. The format of the SEAC meeting is similar to APS School Board meetings in that committee members discuss agenda items and recommendations are made via motions and votes of committee. Public comment is part of the process. Public comment procedures explained.
